**Cancellation by Client:** If the Client cancels the photography session within 14 days before the scheduled date, the deposit will be refunded in full. If the cancellation occurs inside of the 14 days of the scheduled date, the deposit will be forfeited.

**Cancellation by Photographer:** In the unlikely event that the Photographer is unable to fulfill their obligations under this agreement due to circumstances beyond their control, the Client will be entitled to a full refund of any payments made.

**Indemnification:** The Client agrees to indemnify and hold harmless the Photographer against any claims, damages, or liabilities arising out of the Client's use of the images provided under this agreement.

**Governing Law:** This agreement shall be governed by and construed in accordance with the laws of the state in which the session was conducted.
